Waukesha Conservative Farrow Strikes Chord With Mark Belling About Laura Lau *Former Lt. Gov. Farrow: 'Laura Lau has wisdom, intellect, experience we need'*

WAUKESHA COUNTY—MARCH 29, 2018—Former Lt. Governor Margaret Farrow—a Waukesha County Conservative—struck a chord with Conservative Talk Radio Host Mark Belling. During yesterday's radio show, he read the statement below from Farrow who served alongside Governor Tommy Thompson.

Jack Melvin's Misleading Propaganda Compels Former Lt. Governor Margaret Farrow to say:

That means he was paid as a lawyer in the law firm contracted to help with the recount. He has so much to learn about court rooms and litigation. I would prefer that circuit courtroom be held by a veteran whose record is open to all of us making the decision."
