Bipartisan Bill to Ensure Closure of Lincoln Hills Approved

Madison- The troubled youth detention center, Lincoln Hills, will close next year thanks to a bipartisan bill on its way to Governor Evers' desk for approval. The measure closes the facility by the end of June 2021. Lawmakers from both sides of the aisle applauded the bill.

"Closing Lincoln Hills is important, but so is working with our local communities on the best locations for holding youth offenders in the future. I look forward to those discussions and to make sure communities are included."

"The Legislature is committed to closing Lincoln Hills as quickly as possible. The new, hard deadline for closing Lincoln Hills by June 30, 2021 is realistic and achievable.
