### **PPT Coalition Releases Statement on Veto of AB 191**

*July 9, 2021*-In response to the veto of Assembly Bill 191, which would have fully repealed the personal property tax, the Coalition released the following statement:

*The Coalition to Repeal Wisconsin's Personal Property Tax is disappointed that Governor Evers has vetoed bipartisan legislation to repeal the personal property tax (Assembly Bill 191). We are encouraged by the strong bipartisan support the bill had in the Legislature and will continue fighting for full repeal of this unfair and archaic tax.*

*We thank the bill authors, Sen. Stroebel & Rep. Knodl, and the Legislature for passing the bill and working to help the business community during this unprecedented time.*

*Main Street business leaders look forward to working with Governor Evers, the administration and the Legislature to reach a consensus that ends with full repeal of the personal property tax this legislative session.*

The Coalition to Repeal the Personal Property Tax was formed in 2015 and consists of 49 statewide organizations, representing nearly every business in Wisconsin and more than a million employees with a single purpose: to repeal Wisconsin's 175-year old personal property tax.
