Democrats Unveil the RESPECT Act

The RESPECT Act ensures people in Wisconsin have access to comprehensive healthcare and medically accurate information.

Madison – Today Democratic legislators released the RESPECT Act, a pair of bills that ensure patients have access to comprehensive reproductive health services and receive medically accurate information from healthcare providers.

The decision to end or continue a pregnancy is one of the most personal, private decisions of our lives. Every person should be able to make these decisions without political interference. Despite this, Wisconsin legislators have passed laws that restrict access to abortion care and mandate that doctors force biased, non-medical information on patients. These laws interfere with the doctor-patient relationship, contravene science, prevent good medical practice, and harm patients. Political interference in personal health care decisions undermines patient health.

The **RESPECT Act** restores the rights of Wisconsinites to make their own reproductive healthcare decisions, free from harassment, intimidation, political interference, and false information.

Reproductive justice leaders in the legislature and community issued the statements below upon circulation of the bills.

Sen. Kelda Roys, 26th Senate District:

“We all have the right to autonomy over our own body and life. For too long, anti-choice legislators and judges have forced their narrow values on the rest of us, making it as difficult and expensive as possible to receive abortion care. Restrictions on reproductive healthcare disproportionately affect those who are already marginalized, including people of color, young people, poor people, and people who live in rural areas, among others. The RESPECT Act bill restores access to abortion care and demands that patients receive the same high standard of care and honesty that they would in any other medical setting.”

Senator LaTonya Johnson, 6th Senate District:

“The RESPECT Act protects Wisconsinites’ fundamental right to medically accurate information. There is no reason that patients should have to endure intimidation and political interference when it comes to accessing reproductive healthcare. It’s time to put healthcare decisions back in the hands of patients and their doctors by removing these politically driven and unnecessary restrictions.”
