## Speaker Vos Announces Assembly Standing Committees, Chairs

**Madison...**Speaker Robin Vos (R-Rochester) would like to announce the Assembly standing committees and their corresponding chairs for the 2019-2020 legislative session. There are several new committees: Environment; Forestry, Parks and Outdoor Recreation; Criminal Penalties; Medicaid Reform and Oversight; Sporting Heritage; Substance Abuse and Prevention; and Community Development.

“The Assembly will have additional committees this next legislative session to allow for more public input and policy discussions on the important issues facing the state,” said Speaker Vos. “Since the committees are where a majority of the work is done on legislation, this change will have a positive impact on the overall process.”

Speaker Vos will name the vice chairs and the Assembly Republican members of the committees at a later date. The 104<sup>rd</sup> Wisconsin State Legislature begins with the inauguration of the 99 members on January 7, 2019.
